The European University Viadrina is an international and interdisciplinary university that educates around 4,000 students from all over the world in law, economics and cultural studies in the twin city of Frankfurt (Oder)-Słubice on the Polish and German side of the Oder. It lives the European idea in everyday life, promotes European integration in teaching and research and, with around 300 academic and 300 non-academic employees, forms a community that is particularly concerned with successful communication and cooperation with Eastern Europe.

As part of a comprehensive reform agenda, Viadrina is also realigning its legal education. Against this backdrop, the Faculty of Law is seeking to appoint a new

Assistant Professor (W1) for International and European Criminal Law and Criminal Procedure Law with Tenure Track to Full Professor (W3) (m/f/d/x)

The assistant professorship is intended to strengthen teaching and research at Viadrina with a special focus on international and European criminal law and criminal procedure law and to contribute to the development of the university's profile.

The ideal candidate:

- has an outstanding dissertation in the field of international or European criminal law or criminal procedure law, preferably with a comparative dimension,
- is recognizably willing to develop a further research focus on criminal law that strengthens the geographical profile of Viadrina,
- has the potential to publish research results in leading journals,
- is able to teach in the fields of international and European criminal law in German and English,
- is willing to contribute to undergraduate teaching, and
- is interested in developing and acquiring third-party funded projects.

The following qualifications are non-essential, but considered an advantage:

- willingess to develop and employ innovative teaching methods,
- willingness to cooperate with criminal law practitioners and to integrate them into teaching,
- willingness to active involvement in interdisciplinary projects and degree programmes,
- willingness to international collaboration, especially with colleagues in Central and Eastern Europe, particularly colleagues at Adam Mickiewicz University in Poznań.

The call for applications addresses academics in the first few years after conferral of the doctorate, who fulfill the requirements according to section 47 of the Brandenburg Higher Education Act (BbgHG). Candidates who already meet the requirements for a university professorship pursuant to section 43 § 1 no. 4a BbgHG cannot be considered in this selection procedure.

The assistant professorship is initially limited to three to four years and, following a successful mid-term evaluation, is ordinarily extended to a total of up to six years. The timing of the mid-term evaluation and the length of the first contract are determined as part of the appointment agreement prior to the position being filled. The final tenure evaluation, which decides on a permanent appointment, is initiated no later than nine months before the end of the second phase of the assistant professorship. The Statutes for the Evaluation of Assistant Professors and Tenure-Track-Professors at European University Frankfurt (Oder), dated 15 July 2020, govern the procedure and set out the criteria on which the target agreement is concluded.

The European University Viadrina Foundation is actively committed to diversity and equality for all employees, placing particular emphasis on implementing equality and inclusion measures.
